

**THE MINISTER OF HOME AFFAIRS (SHRI BUTA SINGH):**

(a) Prisons being a State subject, the State Governments have been addressed to improve the condition of women in jails. As per information available, no AIDS cases, as such have been reported amongst women prisoners in Calcutta and Madras Jails. However, a few cases of AIDS virus infection among prostitutes detained in Vigilance Homes in Tamil Nadu and West Bengal were reported.

(b) Yes, Sir.

(c) The recommendations were referred to the State Governments. Their implementation is a continuing process. However, the Central Government has been providing financial assistance for upgradation of jail Administration, including separate jails/annexes for women prisoners.

**Guidelines for curbing riots disturbances**

CHIDAMBARAM):** (a) and (b) Maintenance of law and order including curbing of riots and disturbances is the responsibility of the State Governments. Training of police with a view to improve their functional effi-

ciency is, however, constantly emphasised.
