Accidents involving Air India I Aircraft

- (a) the number of accidents which took place in Air India aircraft in India and abroad during the last two years with the reasons in each case; and
- (b) the measures taken to minimise such accidents?

THE MINISTER OF STATE OF THE MINISTRY oF CIVIL AVIATION (SHRI JAGDISH TYTLER): (a) There was only one accident to Air India aircraft which occurred when Boeing 747 Kanishka' VT-EFO crashed off the Irish coast on 23rd June, 1985. A Court of Enquiry headed by Justice B.N Kirpal investigated iato the accident and came to conclusion that the accident was cause<j by explosion due to bomb blast in the forward cargo-hold area.

(b) Action has been initiated to implement the recommendations made by the Court.

Discrimination in mis-carriage maternity benefit to the female employees ln AIIMS

- (b) if not, what benefit is given to the women employees of AIIMS at the time of miscarriage; a'nd how it compares with that give_n to employees of othe_r hospitals; and
- (c) whether section-9 of Maternity Benefit Act is being implemented in respect thereof; and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY (KUMARI WELFARE SAROJ KHAPARDE); (a) and (b) All benefits in accordance with the Central Government orders/instructions issued from time to time are given to the women employees including nurses at the All India Institute of Medical Sciences. The maternity benefits granted to women employees including nurses in AIIMS & other Central Government Hospitals in Delhi are leave for a period not exceeding 6 weeks provided the application of leave is supported by a medical certificate.

(c) The AIIMS has informed that section 9 of the Maternity Benefit Act, 1961 read with Rule 43(2) of the CCS (Leave) Rules, 1972 are being implemented at the Institute.

Appropriation, of rare idols

- 1213. SHRI SUKOMAL SEN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether Government have any authority to appropriate rare idols unearthed by the Archaeological Survey of India or any such agencies or by private efforts, thereby depriving the local area of its past heritage; and
 - (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI); (a) and (b) As per provisions of Section 19 of the Antiquities and Art Treasures Act, 1972, the Central Government has been vested with the power to compulsorily acquire antiquities and art treasures, if it ig of the opinion that it is desirable to preserve any antiquity or art treasure in a public place and that Government may make an Orde_r for the compulsory acquisition of such antiquities or art treasures. As regards the antiquities unearthed by the Archaeological Survey of India, being a Central Government Agency, they become Central Government Property.

However, the Central Government has made adequate provision to control the movement of antiquities under Sections 25 and 26 of the Ancient Monuments and Archaeological Sites and Remain_s Act, 1958 to preserve th_e cultural Heritage ₀f the locality to which it belongs.
