Government of India is implementing a National Oilseeds Development Project in 180 selected districts of 17 States, This project provides financial assistance to farmers on various critical inputs like (i) supply of improved seeds (ii) fungicides and insecticides for seed treatment, (iii) training programmes on package of practices like appropriate seed rate, requisite fertilisers need based plant protection measures, control of weeds through weedisides protective irrigational facilities . etc. NAFED has made arrangements to offer price support to farmers if the market prices go below the support prices declared by Government.
