foreigners, this presents a very dismal picture. There is, therefore, urgent need that steps should be taken by the Government to check this, menace. Steps should be taken to utilise these beggars for some constructive work.

REFERENCE TO THE NEED FOR A MAGNETIC RESONANCE EQUIP-MENT AT THE NATIONAL INSTITUTE OF MENTAL HEALTH AND NEURO-SCD2NCES, BANGALORE.

SHRI G. **MAHESWARAPPA** (Karnataka): Madam Deputy Chairman, the National Institute of Mental Health and Neuro-Sciences, which i3 popularly known as the NIMHANS, at Bangalore, is doing yeoman's service as a premier institution in the field of mental health-and neuro-sciences. Institute is funded by the Government of India and the Government of Karnataka. The of has-been Government Karnataka encouraging this Institute to acquire all modern equipment required for its research and training. Much as it would like to, the State Government alone cannot help the Institute due to paucity of funds. There is absolute need to have a magnetic resonance equipment NMR equipment, which will provide a powerful tool anatomical and obtain functional information in the intact organism without any hazards. This is completely a non-invasive technique. Though there are 200 NMR imaging systems installed throughout the world, we have only one available in our country, at New Delhi. NIMHANS is handicapped duo to the lack of this equipment And this is dependent upon the assistance they receive from New Delhi. This equipment costs about Rs. 3 to A crores. The Director and Professor of Neuro surgery has written to the Government about the urgent need to have a Nuclear Magnetic resonance. The hem Chief Minister of Karnataka also has written to the hon. Minister for Human Resource

Development in this regard. I urge upon the Government that this equip ment be procured and arranged to be installed at NIMHANS Bangalore im mediately.
