THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NA-TURAL GAS AND MINISTER OF STATE IN THE MINISTRY OF FINAN-CE (SHRI BRAHM DUTT): (a) The Gujarat Chamber of Commerce and Industries have represented against the new prices of natural gas fixed by Government.

- (b) to (e) As per the decision taken by the Government recently the basic price gas at landfall points and onshore will be Rs. 1400|1000 M3 and for gas sup-. plied along the HBJ pipeline this would be Rs. 225|1000 M3. In view of the special development needs of North Eastern states a concessional price of Rs. 1000|1000 M3 (with the provision of discounts upto Rs. 50011000 M3) has been fixed. The question of excise duty on lean gas is being considered by the Government. The price structure has been so formulated that on one hand it would encourage use of gas and on other hand provide reasonable return to the gas producing and transporting companies.
- (f) In 1985-86, an estimated quantity of about 3120 million cubic metres of gas was flared. The notional value of this flared gas is Rs. 13. 10 crores. To prevent flaring of gas consumers would be encouraged to take gas on interruptible basis. These fallback consumers would get a 15 per cent discount on the basic price. Special prices would also be fixed for gas from the fields under development.

## Manufacture of large sfee car by Marati **Udyog limited**

- (b) The objectives of setting up of Maruti Udyog Ltd. inter alia, include modernisation of the automobile industry, production of fuel efficient vehicles, be-sfdes production of a 'peoples car' suited to Indian driving and climatic conditions.

- (a) The Supreme Court has laid down detailed guidelines to regulate allotment of Maruti vehicles to various organisations, institutions and individuals out of manufacturers' quota as per the enclosed statement. (See below)
- (b) Maruti Udyog Limited have filed a review application before the Supreme Court of India in this regard.

## .. Statement

As per guidelines laid down by the Supreme Court, allotment of Maruti vehicles out of the manufacturers' quota is to be made in favour of the following categories only.
