THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI AJIT PAN JA): (a) At present there are the following 17 programmes production centres of Doordarshan in the country producing programmes in various languages including regional languages;

## Recommendations of the Fourth Pay Commission regarding pension for ex-servicemen

- (a) what are the recommendations of the Fourth Pay Commission regarding pension for ex-servicemen;.
- (b) whether Government have accepted them, if so, by when these are likely to be announced:
- (c) whether old pensioners are likely to get the same pension-rank for rank; and
- (d) if not, whether Government that it is likely to cause are aware great disappointment and resent amongst the old ment ex-service men?

THE DEPUTY MINISTER IN THE MINISTRY OF PERSONNEL, PUB LIC GRIEVANCES AND PENSIONS (SHRI BIREN SINGH ENGTI): (a) to (d) The main recommendations of the Fourth Central Pay Commission comprise: —

- (i) rationalisation of pension structure;
- (ii) replacement of slab formula by 50% in calculation of pension; and
- (iii) a dearness relief system in-line with that recommended for serving persons.

The Commission has however not found any justification for giving the same pension rank for rank

The report of the Commission is under consideration and Government decisions are expected to be announced shortly.

## RECOMMENDATIONS OF THE PAY COMMISSION

THE DEPUTY MINISTER IN THE MINISTRY OF PERSONNEL PUBLIC GRIEVANCES AND PENSIONS (SHRI BIREN SINGH ENGTI); (a) to (c) The recommendations of the Fourth Central Pay Commission on pension are under consideration of the Government, and decisions will be taken after taking into account all aspects including the views expressed by different sections of pensioners. In the meantime Government has decided to raise the minimum pension and minimum family pension to Rs. 375/- p. m. against Rs. 300/- recommended by the Pay Commission.
