- 3. Delay in processing the licence application.

With the announcement of new software policy, the Department of Electronics have undertaken the following steps: —

- 1. A provision of 30 per cent foreign exchange of the net foreign exchange earned by the exporters is available for marketing activities.
- 2. Software has been allowed to be imported on OGL for actual user.
