Representation from Riot Victims Association regarding payment of bank loans

1040. SARDAR JAGJIT SINGH AURORA: Will the PRIME MINIS-TER be pleased to state:

- (a) whether it is a fact that the Reserve Bank of India, Central Office Bombay has received representation dated 31-1-1987 and also earlier representations from November 1984 Riot Victims Association, Janakpuri, New Delhi' regarding harassment being meted out by the Banks Managements for recovery of relief bank loans in lump sum from the riot victims who are not in a position to repay the loans;
- (b) whether it is also a fact that Government have decided to recover the relief loans in lump sum from the riot victims through courts after initiating legal proceedings; and
- (c) if so, what action has been taken by Government to remove the hardship being faced by the riot victims who are not in a position to repay the bank loans?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) Reserve Bank of India has reported that it has received a representation dated 31st January, 1987 November 1984 Riot Victims Association on 12th February, 1937 regarding recovery of loans. It has advised its Regional Office at New Delhi to look into the complaints.

(b) and (c) Reserve Bank of India issued necessary guidelines to banks vide its circulars dated the 6th, 12th and 14th November, 1984 advising them to provide need-based loan assistance on comparatively softer terms and conditions to the affected persons in November, 1984 disturbances for continuing/re-establishing their production, business and occupation.
