

locusts, which are the most harmful though they appear after a long interval because they cause more damage. Is there any technology mission for this?

**SHRI YOGENDRA MAKWANA:** Sir, we have elaborate arrangements for meeting the situation and there is no necessity for having a technology mission for that.

**MR. CHAIRMAN:** Yes, Mr. Motiram Patel.

**SHRI VITHALBHAI MOTIRAM PATEL:** Sir, the honourable Minister has stated that the danger is more on the Gujarat and Rajasthan border and he has also stated that they are going to construct airstrips. I would like to know from the Minister how many airstrips are going to be constructed in the border areas in Gujarat near Pakistan, what the staff requirement is and how many people have been engaged in this so far.

**SHRI YOGENDRA MAKWANA:** Sir, these are all *kucha* strips for small aircraft which do not require big strips like the regular aerodromes and they are constructed near the borders wherever they are required and wherever it is necessary. The Government of Gujarat and our Organisation also are having the staff.

**MR. CHAIRMAN:** Yes, Mr. Bansal.

**SHRI PAWAN KUMAR BANSAL:** Sir, I would like to know from the honourable Minister whether Punjab is also threatened by the locust invasion and, if so, what special steps would be taken particularly in view of the fact that even during normal times Punjab is not given enough number of aeroplanes for aerial spraying. Would the Government take some steps to ensure that in the event of a threat such as the locust invasion necessary arrangements would be made well in time?

**SHRI YOGENDRA MAKWANA:** It will be done in time, Sir.

गाँतमपुरी, दिल्ली में अधूरी जल-निकास प्रणाली

\*145. श्री सुनील कुमार पट्टनायक  
कुमारी सुशीला तिरिया :

क्या शहरी विकास मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या यह सच है कि दिल्ली के यमुनापार क्षेत्र में गाँतमपुरी के निवासियों को वहाँ सड़कों और नालियों के घटिया या अधूरे निर्माण के कारण काफी असुविधा का सामना करना पड़ रहा है ;

(ख) यदि हाँ, तो नव-निर्माण के कार्य के कब तक पूरा हो जाने की संभावना है और इसमें कितनी धनराशि व्यय किए जाने का विचार है ; और

(ग) क्या इस कालोनी की सड़कों और नालियों का भविष्य में नये सिरे से निर्माण करने के लिए कोई प्रस्ताव सरकार के विचाराधीन है ; यदि हाँ, तो उसका व्यौरा क्या है और यदि नहीं, तो इसके क्या कारण हैं ?

शहरी विकास मंत्रालय में राज्य मंत्री (श्री इलबीर सिंह) : (क) से (ग) 31-12-86 को कालोनी को दिल्ली नगर निगम को अन्तर्गत करने से पूर्व, यमुनापार क्षेत्र में गाँतमपुरी में सड़कों तथा नालियों से संबंधित लगभग 80 प्रतिशत कार्य दिल्ली विकास प्राधिकरण ने पूरा कर लिया था । दिल्ली विकास प्राधिकरण ने बताया कि निष्पादित किया गया कार्य विशिष्टियों के

अनुरूप है। अधूरे विकास कार्यों को पूरा करने के प्रस्तावों को दिल्ली नगर निगम द्वारा प्रतिपादित किया जा रहा है। प्राक्कलनों के तैयार हो जाने के पश्चात् ही, आगे और अपेक्षित व्यय के संभावित व्यौरों का पता चल पाएगा। इस कालोनी में नये सिरों से सड़क और नालियां बनाने का कोई प्रस्ताव नहीं है। तथापि, दिल्ली नगर निगम का अगले वित्तीय वर्ष में सड़कों बरसाती नालियों आदि जैसी सेवाओं में कृटियों में सुधार करने का प्रस्ताव है।

**KUMARI SUSHILA TIRIA:** Sir, the honourable Minister of Health and Family Welfare, on the 4th March 1987, in reply to Question No. 873 said something and now the honourable Minister for Urban Development has mentioned that proposals for completing the incomplete development works are being formulated by the MCD. Sir, Gautampuri Colony in the Trans-Yamuna area is facing a lot of inconvenience due to substandard drainage and roads. I would like to know from the hon. Minister what action the Government has taken regarding sub-standard construction of roads and drainage, and whether any investigation has been made and responsibility has been fixed.

**श्री दलबीर सिंह :** श्रीमन्, माननीया सदस्या ने खास तौर से ट्रांस जमुना एरिया की गौतमपुरी के बारे में पूछा है जिसके बारे में मैं बताना चाहता हूँ कि वहाँ पर लगभग 82 अन-आथराइज्ड कालोनीज थीं जिनको रेगुलराइज किया गया है और उनमें गौतमपुरी भी है। जहाँ तक डी.डी. ए. का सवाल है उन्होंने 80 परसेंट काम कर दिया है। इसके बाद 31 दिसम्बर, 1986 को एम.सी.डी. को ये कालोनीज ट्रांसफर हुई है और एम.सी.डी. प्रोजेक्ट बना रही है ताकि उनमें जो जो कमियाँ हैं उनको पूरा किया जा सके।

**KUMARI SUSHILA TIRIA:** I would like to know whether the Government has prepared any master plan for the outer ring road near Pitampura and other surrounding areas of Delhi during the Seventh Plan.

**SHRI DALBIR SINGH:** This is a separate question.

**MR. CHAIRMAN:** Yes. Next question.

### Separate Cell for Adivasis

\*146. **KUMRI SUSHILA TIRIA:** Will the Minister of WELFARE be pleased to state:

(a) whether there is any proposal under the consideration of Government for the setting up of a separate cell to safeguard the interests of Adivasis in all the Ministries of the Government of India;

(b) if so, what are the details thereof; and

(c) if not, what are the reasons therefor?

**THE MINISTER OF STATE OF THE MINISTRY OF WELFARE (DR. RAJENDRA KUMARI BAJPAI):** (a) and (b) The concerned Central Ministries/Departments having sectoral programmes for Tribal development were advised in 1980 to create cells for formulation, financial provisions and monitoring etc, of Tribal Welfare programmes and these cells have been set up in 12 Ministries.

(c) Does not arise.

**KUMARI SUSHILA TIRIA:** Sir, the hon. Minister has stated that there are 12 Ministries concerned with the development of tribals. I would like to know from the hon. Minister in this regard why very few Ministries prepared plans of action for tribals in their Ministries, and what are the steps taken by the Ministry of Welfare from time to time in this regard?

**DR. RAJENDRA KUMARI BAJPAI:** Sir, the Ministries which are concerned with the tribal programmes have set up these cells, and they have taken up the work. My Ministry, that is, the Welfare Ministry, is the nodal Ministry and all the other Central Ministries have to chalk out programmes in their own sectors. And they are doing it.

**KUMARI SUSHILA TIRIA:** Sir, I would like to know whether the Ministry has issued the guidelines to all Central Ministries for quantification of funds of
