Regularisation of colonies by the DDA

- 158. DR. MOHD. HASHIM KIDWAI; "Will the Minister of URBAN DEVE-LOPMENT be pleased to state:
- (a) the number of colonies regularised by the Delhi Development Authority (DDA) during the year 1985-86 and in the current financial year;
- (b) the number of colonics which have yet to be regularised by the DDA;
- (c) the total amount of money paid to the DDA by the recognised or regularised colonies during the same period; and
- (d) by when the unrecognised colonies are likely to be recognised or regularised by the DDA?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRIMATI MOHSINA KIDWAI): (a) and (b) The D.D.A. had complied a list of 155 unauthorised colonies for consideration for regularisation. Out of them 137 colonies were regularised, 7 are being dealt with as notified slums, regularisation of 7 was rejected and the cases of 4 remain to be finalised. No colony has been regularised by the D.D.A. during 1985-86 or in the current financial year. All the unauthorised colonies in the jurisdiction of D.D.A. have since been transferred to the M.C.D.

(c) Rs. 80,866.71

(d) The cases of the remaining unauthorised colonies will be decided by the MCD in accordance with the policy for regularisation of such colonies covering residential and commercial structures constructed here in upto 30-6-77 and 16-2-77

respectively. It is not feasible to lay down 'any time limit for the purpose.

Exploitation of marine resources

- *159. SHRI SUBAS MOHANTY: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether Government have opened all possible avenues for big companies and multinationals to exploit our marine resources from January 1, 1987;
- (b) whether the steep fall in catchne this season has been taken note of, before going for joint ventures and charter; etc.;
- (c) what were the reasons for ignoring the fall in catches on the East Coast this year;
- (d) whether Government are also aware of the failure of such policies like chartering
- (e) what steps Government propose to fake for protecting fishermen, if catches fall due to such policies; and
- (f) whether any funds have been set apart for compensating small fishermen?

THE MINISTER OF AGRICULTURE (SHRI G. S. DHILLON): (a) Under the new policy of point venture in deep sea fishing with foreign collaboration, applications from large Indian industrial houses and the companies coming under MRTP FERA may also be considered for establishment of joint ventures in deep sea fishing.

- (b) The trend of fish production duriing the first nine months of the year 1986-87 does not indicate any steep fall in cat ches. Fishing vessels under charter and joint ventures would operate in deep sea areas beyond the area of operation of mechanised and non-mechanised boats in order to exploit the deep sea resources. Operation of such vessel would increase fish production and export of marine products.
- (c) The figures available with the Gov ernment do not indicate any fall *m* catch.

- (d) The charter policy of 1981 had limited success. It established the viability of the operation of paid trawlers in our deep sea areas and facilitated transfer of technology, location of commercially via ble resources and marketing tie up for the export of non-shrimp marine products.
- (e) Since-the area of operation of joint venture and charter vessels is different from that of traditional fishermen, no fall in their catch is anticipated. Moreover, suitable steps have already been taken to protect the interests of traditional fishermen.

Location of public utilities above maximum level of flood

THE MINTSTER OF WATER RE-SOURCES (SHRI B. SHANKARANAND): (a) and (b) A model flood plain zoning bill for regulating the economic activities in the flood prone area has been' recommended to the States in 1975 for adoption.-So far only Manipur has enacted such a legislation.

- (b) No fresh contract for imports of NPO has been made. For Rapeseed oil contracts for subsequent shipment periods have been made at lower rates.
