Establishment cost of Food Corporation of India

1167. SHRI SURENDRA SINGH THAKUR: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

(a) what is the establishment cost of FCI per annum;

(b) the extent of establishment cost being passed on to the consumers and shared by Government; and

(c) whether the present establishment cost is exorbitant and an avoidable burden on the consumers?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS AND THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRI H. K. L. BHAGAT): (a) Total Establishment cost of Food Corporation of India during 1985-86 was Rs. 167.84 crores which is 1.60 per cent of the total furn-over.

(b) The difference between the economic \cos_t and issue price is reimbursed to the Food Corporation of India in the form of subsidy, which also includes establishment $\cos t$ as one of the components of handling $\cos t$.

(c) The present establishment cost is only about 4 paise for procurement and distribution of 1kg. of grain which is not considered exorbitant.

Widening the Shahdara-Lonj Road

1168. SHRI D. B CHANDRE GO-WDA: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether Government have since awarded the contract to any party for widening the shahdara Loni Road, Delhi;

(b) if so, what are the details of the party to whom contract has been awarded and under what terms and conditions;

(c) by when the widening work of the Shahdara-Loni Road will be completed by the party; and

(d) if answer to parts (a) and (b) above be in the negative, what are the reasons of delay in awarding the contract?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOP-MENT (SHRI DALBIR SINGH): (a) No, Sir.

(b) Does not arise.

(c) and (d) Technical Sanction to the estimate has been accorded by Competent Authority and the N.I.T. is under scrutiny and approval by the Competent Authority. As such there is no delay in awarding the work. Tenders will be invited on finalisation of the N.I.T. The work is likely to be completed in about one year's time from the date of award of contract.

The report of the Task Force is still awaited.
