Narmada Valley Project

THE MINISTER OF WATER RE-, SOURCES (SHRI B. SHANKARANAND): (a) and (b) The Narmada Sagar Project and Sardar Sarovar Project are under examination from the environmental angle and with, reference to the Forest (Conservation) Act, 1980.

(c) The Narmada Sagar Project will have an installed power capacity of 1000 MW and provide annual irrigation to an area of 1.69 lakh hectares in Madhya Pradesh. The Sardar Sarovar Project will have an installed power capacity *at* 1450 MW. The water will provide annual irrigation to areas of 17.92 lakh ha. in Gujarat, and 0.73 ha. in Rajasthan.
