Profit/loss account of DMS

1198. DR. MOHD. HASHIM KIDWAI: Will the Minister of AGRICULTURE be pleased to state:

(a) the details of profit/loss account of the Delhi Milk Scheme during the last two years; and

(b) the steps taken by Government to minimise the losses, if any?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) During the last two years Delhi Milk Scheme has incurred the following losses: -

1984-85	Rs. 9.50 crores
1985-86	Rs. 7.66 crores.

The losses were mainly because of the lower sale price of the milk than the cost of production.

(b) Several steps/measures have been taken to minimise the losses. The capacity utilisation of the plant has been improved. Constant preventive maintenance and regular monitoring of machines is being done to ensure maximum capacity utilisation. The daily average production/sale of milk also has been increased. Constant monitoring is being done to reduce the raw material cost, FAT/SNF losses, bottle breakages, careful consumption of consumable items etc. Industrial relations have also been improved. Steps have also been taken to modernise/renovate plant and equipment.

Proposed ore dressing plant at Nagpur

1199. SHRI DINKARRAO GOVIND-RAO PATIL: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether Government propose to set up world's biggest ore dressing plant in Nagpur; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF MINES IN THE MINISTRY OF STEEL AND MINES (SHRIMATI RAM DULARI SINHA): (a) and (b) A Modern Mineral Processing Laboratory and Pilot Plant is being set up at Nagpur for beneficiation of various ores and minerals except coal, asbestos and radio-active minerals. The facilities will include a comprehensive mineral processing laboratory, an analytical laboratory, a mineralogical laboratory, an ore dressing plant of capacity from about 250 kgs. to 2 tonnes per hour and a computerised data processing section.

#### Price of potato

1201. SHRI MUKHTIAR SINGH MALIK: Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that prices of potato has fallen considerably even below the cost production; and

(b) if so, whether Government propose to support the agriculturists in realising reasonable price for their produce through the market intervention scheme?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) and (b) In order to ensure that market prices of potato do not fall to unremunerative levels, Government have evolved a market intervention scheme for the crop. Market intervention operations through designated State agencies are authorised by Government, on consideration of proposals received from a State Government which either anticipates that market prices will fall to unremunerative level or finds that this has actually taken place. The level of intervention price is fixed by Government in consultation with the concerned State Government.

For the current (1986-87) crop of potato, Government have agreed in principle to a market intervention scheme in U.P. at the instance of the State Government. Intervention prices have been fixed at Rs. 65 per quintal for the White variety and Rs. 55 per quintal for the Red variety. So far market prices of the specified quality of these varieties have not fallen below the intervention price levels in that State. No such proposal has been received from any other State Government.

#### Procurement price of sugarcane

1202. SHRI MUKHTIAR SINGH MALIK: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

(a) whether it is a fact that a delegation of nearly five hundred farmers from various parts of the county met the Prime Minister during the third week of December, 1986 to seek an increase in the procurement price of sugarcane and payment of arrears to farmers to the tune of Rs. 26 crores; and

(b) if so, whether Government have since considered their demands and decision taken thereon?
