Violation of guidelines for operation of Lotteries

(a) whether the Central Government have issued any guidelines regarding the starting of lotteries by various organisations;

(b) if so, what are the details in this regard; and

(c) whether instances of violation of the said guidelines have come to the notice of Government; if so, what are the details in this regard and what action has been taken thereon?

(c) No specific complaint -regarding private lotteries have been received in recent months. Specific instances are referred to the State Governments and Union Territories who are requested to ensure ad-h'erence to the guidelines. Statement

Guidelines issued to the State Govern-ments Union Territories Administration?

(I) *Weekly lotteries:*

(a) The ceiling on the first Prize may be Rs. 1 lakh. There may be a separate prize for each series.

(b) The maximum price for one tic- ket may be fixed Re. 1/-.

Note: There may be no lotteries withdraws at intervals of less than a week.

(C2) *Bumper draws:*

(a) The ceiling on the first prize may be fixed at Rs. 25 lakhs. ,

(b) The first prize may be made com- mon to all series.

(c) The maximum price of a ticket may not exceed Rs. 3/-.
