THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHINTAMANI PANIGRAHI): (a) to . (c) The Governments of Assam and Nagaland have been requested to suggest and agreed person to be appointed to go into all aspects of the border dispute between the two States, together with agreed terms of reference.

A Tripartite Committee consisting of representatives of Survey of India, Government of Assam and Government of Arunachal Pradesh was set up by the Government of India to consider the question of demarcation of boundary between Assam and Arunachal Pradesh. The Survey of India are undertaking the task of erecting pillars in certain areas. The two State Governments are in touch with each other regarding the boundary problem.

The Governments of Assam and Meghalaya have constituted a Committee Experts headed by Shri Y.V. Chandrachud, formerly the Chief Justice of India by mutual agreement, to consider the question of interpretation of the constitutional boundary between the two States.

MINISTER OF ENVIRON-MENT AND FORESTS (SHRI BHAJAN LAL): (a) Yes, Sir.

- (b) Yes, Sir. The measures taken include the following:
 - (i) Ambient air quality standards have been laid down;
 - limits for major air (ii) Emission polluting industries have been prescrib-

- (iii) The thermal power plants have been directed to install high efficiency
- (iv) A programme for control of pollution from Vehicular exhausts has been launched; and

Electrostatic Precipitators:

- (v) Air quality monitoring stations have been set up.
- (c) Yes, Sir. The Indraprastha power station has been directed to replace three units of electrostatic precipiators which are not functioning satisfactorily. Action has been taken by the power station to replace these units by installing high efficiency electrostatic precipitators. A monitoring cell has also been set up at the Indraprastha Power Station for periodic assessment of performance of the electrostatic precipitators
- (d) Yes, Sir. The proposal includes provision whereby vehicles at the manufacturing stage and those onroad shall have to conform to the emission standards prescribed by the Central Government.
