## Reserve Forest Area in Tripura

1515. SHRI NARAYAN KAR: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) how many acres of land is situated within the area of Reserve Forest in the State of Tripura.
- (b) what is the precentage of land kept within the Reserve Forest area in proportion to the total land of the State;
- (c) how many people are residing in the Reserve Forest area; and
- (d) how many acres of cultivable land are within the Reserve Forest area?

THE MINISTER OF INVIRONMENT AND FORESTS (SHRI BHAJAN LAL): (a) The stee of Reserver forests during-

1985-86 in the State of Tripura was approximately 3862 sq. km.

- (b) The land notified as Reserved-forest is about 37 per cent of the geographical area.

## Release or cultivable land in Tripura declaretgas Reserve Forest area

1516. SHRI NARAYAN KAR: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether any proposal has been sent by the Government of Tripura to the Government of India to release the home-stead of permanent residents and their cultivable land from the Reserve Forest area;
- (b) whether any steps have been taken by the Government of India to release such land; if not, what are the reasons therefor; and
- (c) whether it is a fact that extension of rubber plantation has been hampered as permission is not being given by the Department?

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI BHAJAN LAL):
(a) No, Sir.

- (c) Raising of ruber plantations on forest lands is use of forest land for non-forestry purpose, and as such requires prior permission of the Central Government under the provisions of the Forest (Conservation) Act, 1980. The Gov-rnment of Tripura have submitted mo preposals to the Central Government for raising rubber plantations on forest lame's.
