LDP Ts are likely to be started shortly.

Postal facilities in Madurai District

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI SANTOSH MOHAN DEV): (a) Out of 1091 villages in Madurai Dii^rict post offices exist in 863 villages. On average, each rural post office serves 1. 26 villages. This is a very favourable position considering the fact that in the country as a whole, a rural post office serves, on average, 4. 5 villages. Further, as all villages are visited by delivery agents for delivery'of postal articles and payment of money orders who also sell postage stamps and stationery, book registered letters and accept letters for despatch, the question of a village not having postal facilities does not arise.

(b) and (c) All Postal Circles including Tamil Nadu have been asked to identify areas, particularly hilly, backward and tribal areas, where there is a genuine need for opening of post offices according to the norms prescribed for the purpose. Th view of the ban on creation of posts, the justified proposals are to be referred to the Ministry of Finance for concurrence. It is not practicable at this stage

to indicate how many new P^ost offices are likely to be opened in Madurai District of Tamil Nadu Circle 1987-88.
