of the above, functions at Bhopal. Further, Regional Coaching Centres in Aizwal, Nahar Lagun, Imphal; Agartala, Port Blair, Jamshedpur; Kohima, Shillong and Mandi are located in or near tribal areas.

(iii) The scheme of setting up of Sports Hostels in the country initiated by the Netaji Subhas National Institute of Sports.

(iv) The Scheme of Sports Talent Search Scholarships of the Department implemented by the Netaji Subhas National Institute of Sports.

(v) The scheme of setting up of Field Stations of the Society for National Institutes of Physical Education and Sports (SNIPES) in universities implemented by the Netaji Subhas National Institute of Sports. In Madhya Pradesh, four such field stations in universities at Raipur, Jabalpur, Bhopal and Sagar are functioning.

(vi) Incentive Scheme for promotion of Sports and games in schools through prize money.

(vii) The scheme entitled 'Promotion of Sports in Special Areas' launched by the Sports Authority of India for spotting and nurturing sports talent mainly in tribal areas.

Extension of Railway container service to Trivandrum, Madurai and Trichy stations
