However, improvement is an on going process and it is the constant endeavour of Indian Airlines to bring about improvement in services through measures like-Real Time Computerised reservations, installation of Automatic Ticket Printers at base stations, faster communication system through Single Side Bands (SSBs), Opening of facilitation and complaint counters, special counters for passengers travelling without baggage, introduction of welcome drink, etc.
