Service Conditions of. the Workers of Krishi Vigyan Kendras

2787. SHRI NARAYAN KAR: Will the Minister of AGRICULTURE be pleased to state:

(a) what are the serviceconditions of the workers in theKrishi Vigyan Kendras in differentStates alongwith their wages rates;

(b) whether there is any proposal under Government's consideration for better service rules and wages for these workers; and

Though the scheme on Krishi Vigyan Kendra is sponsored by the Indian Council of Agricultural Research, the service conditions for the staff of the Krishi Vigyan Kendras. are governed by the service conditions of the implementing agencies. The staff appointed under the scheme, whether technical or non-technical are entitled to the specified grades of the respective implementing agencies.
