- (ii) Pollution control camps fire organised to offer technical guidance to the industries for compliance of 'pollution control measures;
- (iii) Fiscal incentives are given for installation o pollution control devices. Subsidies are offered for installation of common effluent treatment plants for small-scale units;
- (iv) Prosecutions have been launched against defaulting units;
- (v) The Environment (Protection) Act, 1986 has been enacted to provide for deterrent penalty including colsure of the polluting units.

## Agreement With Pakistan to prevent Illegal crossborder movements

into practice; if .hot, what are the reasons therefor?

THE MINISTER OF STATE' IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) to (c) During Home^ec-retary's visit to Pakisan on December 20-21 1986 our concern about Pakistan's involvement with Sikh extremists was conveyed in clear-cut terms. Pakistan affirmed its opposition to all forms of terrorism in Punjab •

and elsewhere and indicated that at will not provide any support to terro-' rist activities directed against India.

It was decided to set up two Committees: one to devise fresh, Border Group Rules to help in checking illegal crossings, border crimes, etc., and another to combat narcotic trafficking and smuggling. These Committees are expected to moet in the near future.

## Closing down of shipping service for Haj pilgrims
