STC Scheme to boost exports

THE MINISTER OF COMMERCE (SHRI P. SHIV SHANKAR) : (a) and (b) STC has formulated schemes to enter into high technology export areas. They have signed memoranda of understanding with some public sector units. It will not, however, be in the commercial interest of the Corporation to divulge the details of such schemes/memoranda.
