### Second bridge on Hooghly

2989. SHRI VEERSHETTY MOG-LAPPA KUSHNOOR:

SHRI H. HANUMANTHAPPA:

Will the Minister of SURFACE TRANSPORT be pleased to state :

(a) whether it is a fact that the 2nd Bridge on Hooghly whose foundation was laid by late Prime Minister Shrimati Indira Gandhi a decade ago has been taken up for completion recently after the visit of the present Prime Minister;

(b) if so, the reasons for taking up the work after a lapse of such a long period; and

(c) whether Government have formulated any policy with regard to the works where foundation is laid by Prime Minister?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) No, Sir.

(b) Does not arise.

(c) Second Hooghly Bridge under construction at Calcutta falls on a State Road and is, therefore, primarily the responsibility of the State Government of West Bengal. In respect of National Highway works, foundation stone is laid after the project is approved.

(c) whether an educationist is being considered for appointment to this post;

(d) if so, what are the details thereof; and

(e) whether the DCP on deputation, the policeman and the police driver so appointed are proposed to be sent back to their parent office?
