- (c) The findings of the inquiry officer were examined in the then Ministry of Education and Social Welfare. The exa mination revealed 'hat. the allegation that Dr. Mandan Mishra had made payment to scholars without actually paying amount had not been " proved; the amount figuring in the charge sheet was drawn by Dr. Mishra the mistaken notion that he entitled to it; the Vidyapeeth did not sustain any financial loss and the ir regularities were more in the nature of delayed payments; and the irregularities that took place were not specially contriv ed by Dr. Mishra but were in the uature of inadequacies on account of his being ignorant about the rules.

On the basis of the examination it was decided to communicate to Dr. Mandan Mishra the displeasure of the Chairman of Shri Lai Bahadur Shastri Sanskrit Vidyapeeth Sabha. The displeasure was communicate on 19th November, 1976 along with an admonition that he will not commit similar lapses again.
