Talks between Indian and Ceylonese Prime Ministers at Harare on Sri Lankan Ethnic Issue

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether the Prime Minister had discussions with the Prime Minister

of Sri Lanka during his recent visit to Harare on the issue of peaceful solution to the ethnic problem;

(b) if so, what are the details of the discussions held in this regard; and

(c) by when a final decision on the issue is likely to be reached?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Yes, Sir.

(b) The Prime Minister and the Sri Lanka Prime Minister discussed the issue of the resolution of the ethnic problem in Sri Lanka in the light of the discussions held between the Sri Lankan Government and the TULF in July and August 1986.

(c) Negotiations towards evolving a political solution acceptable to the Tamils and the Government of Sri Lanka are continuing. Those negotiations are at a delicate stage and it is not possible to forecast when a final decision on the issue is likely to be reached.

(d) to what extent deficit financing is anticipated as a consequence thereof and what measures are contemplated by Government to bring down the expenditure?
