- (c) whether a review of TV programme is considered necessary to create social awareness in younger generation?

- (b) Yes, Sir. A study conducted by the Audience Research Unit of Doordarshan indicates that with the present limited transmission and selective viewing by children, there are no visible or apparent harmful effects of television on children.
- (c) It is the constant endeavour of Doordarshan to produce such programmes. With this objective in view, programme formats are continuously reviewed as a normal exercise of programme planning.
