# Delay in the delivery of Telegrams

3099. SHRI BASUDEB MOHAPAT-RA: Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether it is a fact that lack of coordination between the telegraph and engineering wings of the Posts and Telegraphs is resulting in delay in delivery of telegrams, especially in Orissa; and
- (b) if so, what remedial measures Government are taking in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI SANTOSH MOHAN DEV): (a) No, Sir. There is an effective co-ordination between Telegrah and Engineering Wings by holding regular meetings at various levels of management. In Orissa, during last two years, nine such meetings were held.

Ban on foreign contributions to different Institutions Organisations

3100. SHRI SUBAS MOHANTY: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that Government have banned foreign contribution to different institutions organisations in India and if so, which are those institutions organisations: and
- (b) whether Government have received any information about the use of this foreign contribution for political purposes and if so, what action has been taken against those institutions and organisations?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL. PUBLIC GRIEVANCES AND PENSIONS MINISTER OF STATE IN THE MINIS-TRYTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): (a) Following organisations have been prohibited from receiving foreign contribution under the Act, Foreign Contribution (Regulation) 1976:

- (1) Beracah Christian Mission, Trichy (Tamil Nadu).
- (2) Siloam Christian Aid Mission, Trichy (Tamil Nadu).
- (3) Bhoal Technical and Vocational Training Centre, Bhopal (Madhya Pradesh).
- (4) Rural Action in Develoment, Cuddapah (Andhra Pradesh).
- (b) Whenever any instance of violation of the provisions of the said Act is noticed, necessary action is taken in the matter.

#### Forest dwellers

3101. SHRIMATI ELA RAMESH BHATT: Will the Minister of ENVIRON-MENT AND FORESTS be pleased state:

- (a) what is the number of voluntary Agencies Groups working in forest areas or with the forest dwellers in India Statewise:
- (b) what is the number of incidents of violence on volunteers from those agencies during the last two years;
- (c) what is the number of incidents of violence on Government officials, police forest guards; and

(d) what action has been taken or is proposed to be taken by Government to prevent or curb such incidents in future?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI Z. R. ANSARI): (a) to (c). Statistics concerning these matters are not maintained by the Government of India.

(d) In addition to the existing law and order enforcing machinery of the States, a centrally sponsored scheme for development of infrastructures for protection of forests is being implemented from 1986-87.
