Modernisation of Telephone Exchanges in Rural areas

MANOHAR: 3224. SHRI TALARI Will the Minister of COMMUNICA-TIONs be pleased to state:

- (a) what steps Government are taking to modernise the old telephone exchanges in rural areas so as to provide telecommunications services to the consumers; and
- (b) whether Government are planning to replace the small telephone exchanges in the rural areas by bigger exchanges covering several small village exchanges so that direct dialling between several villages is provided?

THE MINISTER OF STATE IN THE COMMUNICATIONS MINISTRY OF (SHRI SANTOSH MOHAN DEV): (a) Rural areas are presently being served by electro-mechanical type auto exchanges and manual exchanges. Manual exchanges are being replaced by automatic exchanges in a phased programme. As a further step, action has been taken to set up the local production of small capacity electronic exchanges. With the availability of these exchanges further improvement in the telecom. services would be achieved.

(b) Replacement of small telephone exchanges by bigger exchanges would depend on the demand, distance among availability of various exchanges and equipment. Provision of direct dailling facility covering several villages is already being provided in several rural where it is feasible.

The plan comprises renovation of existing sewerage works and treatment plants, laying of interceptors for waste waters, installation of pumping stations, diversion of sewage to treatment plants, and use of treated water for irrigation and pisciculture.
