NARAYANAN): (a) Unit-2 of Rajasthan Atomic Power Station is operating in a satisfactory manner Unit-I has been shut down due to re-appearance of new cracks in its south end shield.

(b) and (c) Unit-I of Rajasthan Atom Power Staticri was shut down in March 1982 due to cracks in the south end shield After carrying out repairs the reactor was started on 1-2-1985. The reactor operated till 20-5-1985 when fresh cracks were noticed and once again the was shut down.
