Missing of parcels from cargo terminal of Indira Gandhi International Airport, New Delhi

- (d) whether it is a fact that the International Airport Authority of India has entrusted the security at the Cargo Unit to private Agency; and

- (b) Due to certain teething problems faced during the initial months of the commissioning of the New Air Cargo Terminal Complex at Delhi Airport, nearly 500 parcels had got misplaced at the Cargo Terminal. Almost all of them have since been located and delivered to the Consignees.
- (c) Does not arise in view of (a) and (b) above.
- (d) and (e) For administrative expediency, the watch and ward functions on the land-side of the Cargo terminal only has been entrusted to a private agency. The security on the air-side is with the Director of Civil Aviation Security.
