Rail mishaps due to defective couplings

- 212. SHRI HARVENDRA SINGH HANSPAL: Will the Minister of RAIL-WAYS be pleased to state;
- (a) whether Government have constituted a high power committee to go into the problem of parting of railway coaches due to defective couplings and thus causing mishaps;
- (b) if so, by when the said high power committee is likely to submit its report to Government:
- (c) whether it is a fact that some persons were killed and injured due to detachment of couplings in some of the recent train accidents; and
- (d) if so, the details thereof and the steps Government propose to take to stop recurrence of such accidents in future?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SINDIA); (a) Yes, Sir.

- (b) The committee is likely to submit its report by December, 1986.
- (c) and (d) One train accident has occurred since January 1986 due to detachment of coupling of a goods train in mid-section near Garwa Road. In this case a collision occurred between parted load of the goods train and 162 Dn. Amritsar-Tatanagar Express

Checks on the condition of couplers in workshops and at the train examination points have been intensified. Necessary steps will further be taken on the basis of the recommendations of the high power committee.

THE MINISTER OF STATE IN THE DEPARTMENT OF HEALTH IN THE MINISTRY OF HEALTH AND FAMI-(KUMARI SAROJ LY WELFARE KHAPARDE): (a) to (c) The draft Revised Strategy for the National Family Welfare Programme includes, inter (1) developing multi-sectoral linkages between the Family Welfare and other socio-economic developmental programmes, (2) professionalising the Information, Education and Communication activities, (3) ensuring full community participation by constitution of popular committees, (4) Improving programme management and adopting differential area and group specific approaches, and (5) Improving technical quality of services. The objective of this strategy is to ensure the achievement of the demographic goal of NRR-1 by 2000 A.D.

THE MINISTER OF STATE IN THE DEPARTMENTS OF YOUTH AFFAIRS AND SPORTS AND WOMEN AND CHILD DEVELOPMENT IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI MARGARET ALVA): (a) 60 ICDS projects

have been sanctioned to Orissa till 31.3. 1986. 24 more ICDS projects have been sanctioned during the current year, i.e. 1986-87. Monthly Progress Reports received from 51 projects, as on 30 September 1986, indicate that 44 projects have become fully operational. In these projects, 2.85 lakh children and 0.60 lakh mothers were getting supplementary nutrition and 1.29 lakh children were attending pre-school education classes.
