- (d) whether it is a fact that an International Seminar on role of local Government in Development was held in Delhi in the month of October, 1986; and
- (e) if so, what suggestions recommendations were made at the seminar and what is the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOP-MENT (SHRI DALBIR SINGH): (a) Yes, Sir.

- (b) The 'Pull' of the urban areas on account of employment opportunities and availability of basic services and 'Push' of the rural areas where agricultural lands are over-saturated leads to rural-urban migration. This is essentially a socio-economic phenomenon.
- (c) In order to ensure a balanced distribution of urban population and to slow down the growth of metropolises a Centrally sponsored scheme of Integrated Development of Small and Medium Towns was introduced in the year 1979. Up to the end of Sixth Five-Year Plan 235 towns were covered under the Scheme. This scheme is being continued in the Seventh Five-year Plan to cover 102 additional towns.
 - (d) Yes, Sir.
- (e) The suggestions/recommendations are still awaited.
