

Harijans/Adivasis killed in Bihar

3361. SHRI CHATURANAN MISHRA: Will the Minister of WELFARE be pleased to state:

(a) whether it is a fact that large number of Harijans and Adivasis are being killed in Bihar;

(b) if so, the number of persons killed in the years 1983-84, 1984-85, 1985-86 and 1986-87; and

(c) what steps have been taken in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF WELFARE (SHRI GIRIDHAR GOMANGO): (a) and (b) The number of cases of murder of Scheduled Castes and Scheduled Tribes during the years 1983 to 1986 in the State of Bihar is indicated below:-

Year	Scheduled Castes	Scheduled Tribes
1983	71	9
1984	95	10
1985	54	12
1986 (upto March)	13	Nil

(c) The Government of India have issued comprehensive guidelines from time to time for effectively dealing with atrocities against Scheduled Castes/Scheduled Tribes. These guidelines contain precautionary, preventive, punitive and rehabilitative measures.

(d) by when Government propose to bring some consistency in the kind of packages permitted?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI GHULAM NABI AZAD): (a) No, Sir.

(b) Yes, Sir.

(c) and (d) The pack sizes permitted under the Standards of Weights and Measures (Packaged Commodities) Rules, 1977 are in metric system and there is an element of consistency in them. However, these are reviewed from time to time in the light of the suggestions received from the States/Union Territories, voluntary consumer organisations and other concerned interests.

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH):

(a) to (c) Some representations have been received through MPs alleging assessment of incorrect damages but DDA has denied that assessment of damages in respect of the refugees of Ahata Kidara, Sadar Bazar, Delhi, who are covered by Gadgil Assurance, has been done' incorrectly treating them at par with non-refugees. Assessment of damages is in the nature of quasi-judicial proceedings under the public Premises (Eviction of Unauthorised Occupants) Act and the parties can go in appeal to Session Court in case they feel aggrieved.

Atrocities on Harijans in Uttar Pradesh

Increase in the number of marginal farmers and agricultural labourers

3365. SHRI SURAJ PRASAD: Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that there has been an increase in the number of marginal farmers and agricultural labourers in the country during the last 3 years;

(b) if so, what are the reasons therefor, and

(c) what steps have been taken to arrest this trend?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT IN THE MINISTRY OF AGRICULTURE (SHRI RAMANAND YADAV): (a) Statistics on the number of marginal farmers and agricultural labourers in the country during the last 3 years is not available. However, the five yearly agricultural census of operational holdings and decennial population census do indicate an increase.

(b) The possible reasons for increase in the above two categories could, among others, be attributed to fragmentation of holdings due to increase in population and partition in the family, acquisition of land, particularly for major projects, poverty, inadequate allotment of land under land distribution programmes to the landless poor etc.

(c) While steps taken to check the growth of population may also have the effect of restricting the extent of fragmentation of holdings, various poverty alleviation programmes including distribution of land to landless rural poor are being executed with a view to ameliorate the economic conditions of marginal farmers and agricultural labourers.
