- (a) whether the Public Accounts Committee, in its report tabled in Parliament on 24th Febuary, 2006 had stated that the trend indicates that extraneous consideration seems to have weighed with the concerned authorities while admitting students to Kendriya Vidyalayas;
- (b) whether from 1.37 per cent in 2001-02, the share of students admitted on the Ministry's recommendations leapt to 23.97 per cent in 2004-05;
- (c) whether their gain has ment a loss of seats for Government employees' wards whose share in admissions fell from 56 per cent in 2001-02 to 43 per cent in 2004-05; and
 - -(d) if so, the rationale and justification thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) Yes, Sir.

- (b) No, Sir. as per Admission Guidelines of Kendriya Vidyalaya Sangathan (KVS), only 100 seats are allocated for the children of the employees of the Ministry of Human Resource Development over the above the sanctioned strength on the recommendation of the Ministry. This constituted 0.09% of fresh admissions in 2001-02 and 0.06% in 2004-05.
- (c) and (d) No. Sir. However, there has been a decrease in share of transferable Central Government emplyees' wards in the total admissions mainly because of opening of new schools in areas not having large presence of transferable Central Government employees.

Survey of Kendriya Vidyalayas

- (a) whether Kendriya Vidyalaya Sangathan has conducted any survey of the achievement level of its students at upper primary and elementary level:
 - (b) if so, the results thereof;
 - (c) if not, the reasons therefor;

- (d) whether Kendriya Vidyalaya, INA Colony undertakes any quality assessment of its students at upper-primary and elementary level and also involvement of teachers to improve quality of students; and
 - (e) if so, the result thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) Kendriya Vidyalaya Sangathan (KVS) has conducted a survey through Learners Achievement Test for class V students of Kendriya Vidyalayas in April 2006 with standardized question papers in Maths, English and Environment studies. The results are given in the enclosed Statement (See below).

- (d) and (e) Kendriya Vidyalaya, INA Colony was not part of the survey on the Learners Achievement Test. However, Kendriya Vidyalaya, INA Colony assesses achievement of its students regularly through unit tests, and half-yearly and session-ending examinations.

Statement

Survey results of Kendriya Vidyalaya Sangathan

Four Kendriya Vidyalayas on random basis from each of 18 regions (one each from Civil Sector, Defence Sector, Project Sector and Remote area) were selected for administration of the test.
