## Drought situation in Maharashtra

3308. SHRI JAGESH DESAI: SHRIMATI SURYAKANTA JAYAWANTRAO PATIL: SHRI VITHALRAO MADHAV-RAO JADHAV:

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Government are aware the drought situation of Maharashta;
- (b) the number of villages facing -drinking water problem at present and affected on account of failure of crops in Maharashtra and the number of problem villages likely to be provided drinking water in the financial year:
  - (c) the extent of financial assistance provided by the entral Government to Maharashtra as against their demand and in which form; and
  - (d) whether any central team was sent to drought hit areas of Maharashtra and if so, what are their commendations?
  - THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICUL-TURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHR<sub>I</sub> YOGENDRA MAKWANA): (a) Yes, Sir.
  - (b) In their Memorandum seeking Central assistance for drought relief, the State Govt. has reported 4829 villages have been affected due to drought conditions. The State Government has also reported that at present about 354 villages facing acute shortage of drinking water. Though detailed information is not available with the Govt. Maharashtra they have sought assistance on an adhoc basis assuming that 15.000 villages would be affected by drinking water scarcity by June, 1987.
    - (c) and (d) The Memorandum was received on 12 Nov. 1986 and a Cent-

ral Team has scheduled a visit the State from Dec. 9, 1986 to assess the drought situation and the requirement of Central assistance.

## Itchampalli Project in Andhra Pradesh

3309. SHRI PARVATHANENI UPE. NDRA: Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether the Central Government has received any propofrom the State Government Andhra Pradesh for Itchampalli project to control the floods in Godavari river:
- (b) if so, the total area to be irrigated by this project and details of power generation; and
- (c) the present stage of the project: and by when the project is likely to: be cleared?

THE MINISTER OF WATER RE-SHANKARA-SOURCES (SHRI B. NAND): (a) and (b) The preliminary report on Itchampalli Project received in 1980 in Central Water Commission from Andhra Pradesh does not contained provision for flood control in Godavari. It envisages irrigation of 1.21 lakh hectares and power generawith installed capacity of 660 MW.

(c) Detailed Project Report has not been received so far.

## Exploration of mineral wealth in Andhra Pradesh
