

**Losses suffered by SAIL**

508. SHRI KAPIL VERMA; Will the Minister of STEEL AND MINES be pleased to state:

(a) what is the extent of loss suffered by the Steel Authority of India Limited during the last six months;

(b) What measures Government are taking to reverse the trend;

(c) by when losses are likely to be made up; and

(d) what is the quantum of steel likely to be imported during this year as compared to the preceding year

THE MINISTER OF STEEL AND MINES (SHRI K. C. PANT): (a) and (c) SAIL has incurred' a loss of Rs. 132. 16 crores during the first six months of the current financial year (1986-87). However, it expects to end the year with a profit.

(b) SAIL is making continuous, efforts to improve its profitability by increasing its total production, improvement in its techno-economic parameters, improving maintenance of plant and equipment for better availability and taking steps to ensure adequate inputs and of the right quality. Steps are also being taken to bring about a change in the work culture conducive to higher production and productivity and implement cost reduction measures.

(d) The import plan for 1986-87 provides for import of 1. 55 million tonnes of carbon steel under canalised and supplementary licensing systems as compared to the plan of 2. 49 million tonnes for 1985-86. No estimate on OGL and other direct imports are available. Data on actual imports during last year and the current year are yet to be published by the DGCI&S.
