(b) if so, what are the measures taken by Government to minimise the loss in Steel Authority of India Limited and increase production of steel in the coming years?

**THE MINISTER OF STEEL AND MINES (SHRI K.C. PANT):**

(a) During the period April-October, 1986 the five integrated steel plants of SAIL lost a production of 9,56,000 tonnes as compared to their targets. SAIL has computed that out of this lost production, the loss on account of power restrictions by public utilities was 4,76,000 tonnes.

(b) SAIL have taken the following measures to minimise loss and to increase production of steel :

—optimisation and augmentation of captive power generation.

—ensuring adequate availability of inputs of the right quality and in the required quantity particularly of coking coal, including import of low ash coking coal.

—moulding a better work culture which focusses primarily on better team work and higher levels of discipline.

—systematic maintenance of equipment.

—strict adherence to technological norms.

—modernisation and technological upgradation.

—R&D efforts for improving productivity and efficiency.
