**Setting up of a National Institute of Disaster Management at Hyderabad**

452. SHRI PARVATHANENI UPENDRA: Will the Minister of AGRICULTURE be pleased to state:

(a) whether any proposal has been received from the Government of Andhra Pradesh for setting up a National Institute of Disaster Management at Hyderabad;

(b) if so, whether any decision has been taken in the matter; and

(c) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YO-GENDRA MAKWANA): (a) Yes, Sir.

(b) and (c) The proposal from the Government of Andhra Pradesh has been received in the context of a VII Plan scheme for establishment of a National Institute of Disaster Management by the Government of India. No decision has yet been taken by the Government of India, on the setting up of such an institute.

**Shifting of Headquarters of the Animal Welfare Board**

453. SHRI ALADI ARUNA *alias* V. ARUNACHALAM: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government propose to shift the Headquarters of the Animal Welfare Board from Madras » Delhi; and

(b) whether it is a fact that the Animal Welfare Board has discontinued its services to the animals suffering from injuries and illness in Madras ?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YO-GENDRA MAKWANA): (a) A Resolution was passed by the Animal Welfare Board of India at its meeting held on the 25th August, 1986 to shift its Headquarters from Madras to New Delhi. No decision has been taken in this regard.

(b) Veterinary services were temporarily discontinued in Madras but have been resumed with effect from 6th October, 1983.

**Improvement in the working of CPWD Enquiry Offices in Government Colonies**
