(c) whether a licence for the purpose has been granted to M/s. Maruti Udyog Ltd; if so, what is the estimated cost of the expansion project?

It envisages production of a 'three-box' car with two option of engine, viz. 1000 cc and 1300 cc in addition to the existing 800 cc car. The matter is under consideration of the Government.

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUS-TRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY (SHRI M. ARUNACHALAM): (a) and (b) Two applications, one from Ms. Oswal Agro Mill<sub>s</sub> Ltd., New Delhi and another from M/s. Bindal Agro another Chem. Ltd., Ludhiana, have been received for the import of Designs and Drawings from M/s AS-AF Corpn. Itd., Japan, for the manufacture of Portable Rice Milling Machines. The first application from M/s. Oswal Agro Mills Ltd., New Delhi has already been rejected. The second application is still under consideration.
