tral mine planning and design Institute haj developed a new technology of mechanised production of domestic coke. In process of production of mechanised domestic coke, every care has been to keep the working areas free of pollutant through inclusion of suitable pollution control measures. Coal is devolatilised to yield domestic coke while gas leaving the retorts in the plant is subjected to spraying and cooling before it passes through the exhauster and scrubber where bulk of the tar contained in the gas is separated out. The tar-free gas is then partially recycled for improving productivity and yield of tar. The yield of domestic coke will generally be in the range of 70 to 80 per cent of coal devolatilised. The yield of such tar can normally vary from 1, 25 per cent to 1. 75 percent of coal devolatilised depending on the nature and quantity of volatile matter present in the coal.

- (a) whether it is a fact that there in an acute shortage of Acitrom, a life saving drug for persons who have under gone heart surgery for value replacements; and
- (b) if so, what are the reasons therfor and the steps being taken to meet the shortage of this life saving durg?

THE MINISTER OF STATE IN THE DEPARTMENT OF CHEMICALS AND PETRO-CHEMICALS IN THE MINISTRY OF INDUSTRY (SHRI R. K. JAICHANDRA SINGH): (a) Reports of shortage of Acitrom tablets were received from some State Drugs Control Authorities and others.

(b) The producer company M's S. G. Pharmaceuticals, Baroda have informed that the shortage was due to disruption in production for 2|3 months because of non-availability of intermediates required in. the manufacture of the bulk drug. The company has now overcome the difficulties and resumed normal production. Rased on this Ministry's advice, the company has already rushed sufficient stocks to various parts of the country.

Wrong address of Union Carbide Corporation

- 642. SHRI TALARI MANOHAR: Will the Minister of INDUSTRY be pleased) to state;
- (a) whether it is a fact that Gov ernment had given wrong address of Union Carbide Corporation leading to further avoidable delays as reported in the Times of India of 10th October, 1986; and
- (b) whether Government will make inquiries and fix responsibility in the matter?

THE MINISTER Or STATE LN THE DEPARTMENT OF CHEMICALS AND PETRO-CHEMICALS LN THE MINISTRY INDUSTRY (SHRI R. K OF JAICHANDRA SINGH): (a) Since Union is a New York Corporation, incorporated under the laws of New York, in the plaint a reference was made to the available address of Union Carbide Corporation (U. C. C.) in New York. Under Code of Civil Procedure summons could be served to the Corporation at its registered office. Summons have since also been issued to the address of U. C. C. in Danbury in the State on Connecticut. Advocates on behalf of Union Carbide Corporation had appeared in the Court of District Judge, Bhopal on 30th October, 1988.

(b) Does not arise.
