SHRI PARVATHANENI UPENDRA: Why- don't you come with me, I will take you.

SHRI MUFTI MOHD. SAYEED: Sir, the occupancy in Ashok Hotel is 84 per cent now a days and in Samrat Hotel it is 74 per cent. So occupancy has increased.

SOME HON. MEMBERS: Including cockroaches.

MR. CHAIRMEN; Mr. Minister what he has asked about is not occupancy but standard of comfort, hygiene arid so on.

SHRI MUFTI MOHD. SAYEED; Sir, because of improvement in maintaining arid upkeeping of the hotels, the occupancy has increased... (*Interruptions*).

SHRI PARVATHANENI UPENDRA; Why don't you come with me, I will show you the conditon of the Ashok Hotel or you take

SHRI MUFTI MOHD. SAYEED: Please come with me.

SHRI VISHWANATH PRATAP SINGH; Sir, mosquitoes and cockroaches go with the opposition... (*Inter*-Vuptious)...

SHRI PARVATHANENI UPENDRA; They also come to complain against you.

SHRI G. VARADARAJ: Sir, I had the opportunity of visiting the Ashok Hotel at Bangalore as a Member of the Committee on Public Undertakings. The treatment at the hotel was excellent. But the next day when, I went there it was quite opposite. Nobody bothered to look after. So this is the situation.

SHRI MUFTI MOHD. SAYEED: Lot of improvement has been done in the hotel.

SHRI G. VARADARAJ; I am talking about the last month, when I went there as a member of the Committee on Public Undertakings. The

treatment was so good that every half-an-hour they used to ring up: Are you comfortable, Sir? the third day when i went there, nobody bothered to look at me at all. That is now a normal traveller is dealt with in ITDC hotels.

Also, if you go the Bangalore airport ITDC restaurant, you will not get anything there, I would like to know what action the Ministry proposes to take to improve the facilities at Bangalore and other airport restaurants.
