- (i) Indore-Dohad BG Line (182 kms)

Survey has been completed and is under consideration of Planning Commission. Estimated cost is Rs. 83 crores.

(ii) Satna-Rewa BG Line (50 kms)

Survey completed and work included in 1985-86 Railway Budget. Planning Commission have yet to clear this project.

(iii) Dhah Rajhara-Jagdalpur BGline (234 kms)

Reappraisal of the earlier survey is in progress. Report for first phase from Dhali Rajhara to Rowghat (95 kms) has been submitted. Estimated cost is Rs. 61.88 crores.

(iv) Rewa-singarauli BG line

Survey was earlier conducted for this line. Now Final Location survey for BG line between Rewa and Beohari (105 kms) is in progress. Rail line exists between Beohari and Singarauli.
