(iii) Devising a formula for removal of stagnation among Selection Grade Teachers; and

(iv) Consideration of the demand for introduction of Professor's Grade in Colleges.

Action has been taken to implement all these assurances except the last one, namely, introduction of Professor's Grade in Colleges, which is still under consideration. There is no ground for any unhappiness among teachers.
