THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICA\_ (SHRI SANTOSH MOHAN DEV): (a) Yes, Sir. However, the agitation was called off on 8.11.1986.

- (b) (1) Revision of pay scale of Junior Engineer from scale of 1400-2300 to Rs. 1640-2900 and Selection Grade scale to Rs 2000—3200.
- (2) Change in the promotion rules to Assistant Engineers to allow for promotion on the basis of senioritycum-fitness rather than by the selection:
- (3) Question of pay fixation under FR 22(C) for JEs promoted from the cadre of Selection Grade Phone Inspectors, Transmission Assistants etc.
  - (c) Yes, Sir,
- (d) The extent of loss of direct revenue is approximate Rs. 50 lakhs per day and indirect loss cannot be readily estimated.
- (e) The Government have appointed a High Power Committee to examine the demand of revision of pay scales of JEs. The question of amend. ment to Recruitment Rules 1981 is being expedited and the issue of restoration of FE 22(C) for fixation of pay of Junior Engineers promoted through Selection Grade Phone Inspectors, etc. and the deduction of pay because of refixation of pay under FR 22(a) is being taken up at a very high level for early and favourable settlement.
