Infrastructure Development projects relating to water supply, sewerage, sanitation and other urban services. a proposal to set up an Urban Development and Urban Water Supply Financing Corporation is under the consideration of Government. In the Central sector of the Seventh Five Year Plan, there is a total provision of Rs. 55 crores for the setting up of this Corporation.

## Supply of additional quota of rice to Andhra Pradesh

\*178. SHRI PRAVATHANENI UP-PENDRA: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state.

- (a) whether Government have received any request from the Andhra Pradesh Government for releasing additional quota of rice to the State in view of the unprecedented floods in which standing crop in about 20 lakh acres of Krishna-Godavari deltas, estimated to yield 12 lakh metric tonnes of rice, was razed to the ground;
- (b) if so the decision taken by the Central Government in the matter; and
- (c) whether the Central Government propose to enhance the quota of rice to Andhra Pradesh keeping in view the Rs. 2/- per kilogram rice scheme being carried on by the Government of Andhra Pradesh for the benefit of the poor people?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND MINISTER OF FOOD AND CIVIL SUPPLIES (SHRIH K. L. BHAGAT): (a) Yes. Sir. The Government of Andhra Pradesh has requested for a special one-time allocation of 5 lakh tonnes of rice over and above their normal allocation in 1986-87 (November-October).

(b) and (c) The Government of Andhra Pradesh has been allotted a quantity of 1.25 lakh tonnes of rice for the month of November, 1986, as against a quantity of 1.15 lakh tonnes

during November, 1985 and 80.000 tonnes during November, 1984. The allocations are made on a month to month basis.

## Encroachment of land alloted to all India Institute of Medical Sciences, New Delhi

\*179. SHRI B. SATYANARAYAN REDDY: Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) whether it is a fact that the land allotted to the All India Institute of Medical Sciences in the Andrews Ganj area of New Delhi have been encroached upon by some jhuggi dwellers;
- (b) if so, what are the steps proposed to be taken to clear the encroachment; and
- (c) the projects proposed to be set by the All India Institute of Medical Sciences on the said land?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRIMATI MOHSINA KIDWAI) (a) Yes, Sir.

- (b) The Delhi Development Authority which has been approached by the Institute for clearing the encroachments has asked for shifting charges from the Institute in order to rehabilitate the jhuggi dwellers elsewhere.
- (b) All India Institute of Medical Sciences proposed to construct staff quarters and also to utilise it for future expansion of the Institute.

## Clearance to Narmada Sagar Dam and Sardar Sarovar Projects

- \*180 SHRI ALADI ARUNA alias V. ARUNACHALAM: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether the Central Government have given clearance to the projects of Narmada Sagar Dam in Madhya Pradesh and Sardar Sarovar in Gujarat; and
- (b) the financial assistance likely to be given by World Bank for these projects?

(b) World Bank has signed an agreement for an assistance of \$300 million for dam and \$150 million for canals of Sardar Sarovar Project.

Narmada Sagar Project has also been appraised by the World Bank for an assistance of \$400 million. Further negotiations have not been possible in the absence of clearance of this project from environmental angle.

लिया जाता है। पिछले तोन महानी के दौरान इस क्षेत्र से 71 पशुग्रों की पकड़ा गया था। इसे रोकने के लिये नई दिल्ला नगर पालिका द्वारा यह ग्रिभयान तेज किया जा रहा है।
