ARUNACHALAM); No, Sir; Only districts having no large or medium scale industries are identified as 'No Industry Districts'. Ganjam district is not eligible for inclusion in the list of 'No Industry Districts'.

## **Developing Non-conventional sources** of energy

(d) whether the Union Government provides some assistance to State Governments for this purpose and if so, what are the details in this regard?

THE MINISTER OF **ENERGY** (SHRI VASANT SATHE) (a) (d) . All the State Gov ernments have drawn up plans- to develop non-conventional sources of energy. The plans aims at harnessing Solar Energy, Wind Energy, Bio-Energy, installation of Improved Chuiha etc for 'generation/saving of during. energy the Seventh . Plan period. An outlay of Rs. 100.69 crores has been approved by the Planning Commission in the State sector for developing conventional sources of energy in the States. The implementation of the prog-Igrammes is being reviewed on actual basis at the time of Annual Plan discus sions in the Working Group for Non-Conventional Sources of Energy gramme. During the Annual Plan dis cussions the allocations are made for the next year for developing new and on-going programmes of non-conventional sources of energy.

In addition to the outlay approved by the Planning Commission in the State sector, the Central Government provides technical and financial assistance to the State Governments for developing nan-conventional sources of, energy. This assistance depends upon the targets for the various programmes fixed for different States in consultation with them and or on the basis of technically viable projects emanating from them.
