THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DE-VELOPMENT IN THE MINISTRY ARUNACHA-INDUSTRY (SHRI M. LAM): (a) and (b) As on 31.10.1986, twelve applications received under provisions of Industries (Development & Regulation) Act, 1951 for the grant Letters of Intent for locating industries in Orissa are at various stages of consideration. Of these, four applications pending for about six months, five applications for four months and the rest have been received recently. It is the constant endeavour of the Government to dispose of all pending applications as expeditiously as possible.

ENERGY THE MINISTER OF VASANT (SHRI SATHE): (a) Gov-All the State to (d) ernments have drawn up plans to develop non-conventional sources of energy. The plans aims at harnessing Solar Energy, Bio-Energy, installation Wind Energy, Chuiha Improved generation/saving of energy during Seventh Plan period. An outlay of Rs. 100.69 crores has been approved by the Planning Commission in the State sector for developing conventional sources of energy in the States. The implementation of the proggrammes is being reviewed on actual basis at the time of Annual Plan discussions in the Working Group for Non-Conventional Sources of Energy Pro-During the Annual Plan disgramme. cussions the allocations are made for the next year for developing new and on-going programmes of non-conventional sources of energy.

In addition to the outlay approved by the Planning Commission in the State sector, the Central Government technical and financial assistance to State Governments for developing conventional sources of energy. This assistance depends upon the targets for the various programmes fixed for different States in consultation with them and or on the basis of technically viable projects emanating from them.
