Setting up of financial institutions for small industries

1274. SHRI K. VASUDEVA PANICKER: Will the Minister of INDUSTRY be pleased to state:

(a) whether Government propose to set up financial institutions to cater to the needs exclusively of small industries; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY (SHRI M. ARRUNA-CHALAM): (a) and (b) Government of India have set up a small Industries Development Fund (SIDF) under the Industrial Development Bank of India (IDBI) with effect from 20-5-1986. The SIDF will provide assistance to the SSI Units for development, expansion diversification, modernisation and rehabilitation. Such assistance will be routed through State Financial Corporations (SFCs), State Industrial Development Corporations (SIDCs), commercial banks, cooperative banks, regional rural banks (RRBs) and other eligible institutions. It will, also provide assistance by way of rediscounting of bills and promissory notes arising out of sale or purchase of machinery by small scale units on deferred payment terms. Besides, SIDF will assist institutions engaged in the promotion, financing and provision of extension services to the small scale sector. To start with, the Fund will have a corpus of about Rs.2500

crores. The Fund has been created with an initial cash contribution of Rs. 100 crores from the Bank's General Fund.
