**difference between cost of off shore and on shore drilling**

1312. SHRI CHIMANBHAI M EHTA:  
SHRI SAGAR RAYKA;

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether it is true that on-shore drilling of oil is almost one seventh of that of off-shore drilling; if so, what is the difference in drilling cost between onshore and off-shore drillings;

(b) what percentage the on-shore and the off-shore drillings constitute in crude oil as well as natural gas;

(c) whether it has been the policy of Government to lay more emphasis on onshore drilling in view of its low drilling cost;

(d) whether technical possibilities were examined for diverting the oil-reserves which are being drilled out off-shore to the areas where on-shore drilling is possible; if so, what is the cost of diverting underground reserves and whether the same works out to be cheaper in the long run in view of low drilling cost; and

(e) if no, whether Government propose to do so?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI BHAHM DUTT): (a) In 1985-86, 520, 400 metres drilling was done onshore and 188,500 metres off-shore.

The cost ratio of onshore and offshore bearing.

(b) For crude oil and natural gas the percentage drilling onshore and offshore during 1985-86 was :—

On-shore .....	73 per cent
Off-shore .....	27 per cent
Total	100 per cent

(t) No, Sir. Apart from costs, choice of areas for exploration also depends upon prospectivity, geology, logistics etc.

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI BRAHM DUTT): (a) Drilling was in progress at the following locations;

(c) So far ONGC have completed 17 wells in onshore. Hydrocarbons have been discovered in 9 wells.

In offshore 31 wells have been completed; 7 have proved to be hydrocarbon bearing.
