THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL. PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE MINISTRY AFFAIRS HOME (SHRI OF Р CHIDAMBARAM): (a) and (b)> The promotions of officers of AH India Services who are eligible for such promotions 'are based on an overall assessment of their record and performance in their career. A good record in field assignments will get reflected in 'his assessment.

(c) and (d) The women officers are considered alongwith other officers for promotion according to general instructions. Guidelines have been issued from time to time for career development of direct recruits in the IAS. Recently guidelines were issued laying emphasis on the placement of women officers in order to equip them for positions of higher responsibilities. It has been advised that adequate opportunities may be given to them to hold important field level assignments and in diverse areas of administration.
